The NASDAQ Stock Market LLC ("NASDAQ") is filing this Partial Amendment No. 1 to SR-NASDAQ-2012-124. Partial Amendment No. 1 makes the following related changes to the filing:

- 1. On pages 4-5 and page 10 of the original filing, delete the sentence "NASDAQ is also adding Rule 7470A (Exemption to the Order Recording and Data Transmission Requirements) as a replacement for former Rule 6958, which lapsed in July 2011, and deleting Rule 6957 (Effective Date)." and replace it with the following sentences: "NASDAQ is also deleting Rule 6957 (Effective Date), redesignating Rule 6958 as Rule 7470A, and amending that rule to reinstate its effectiveness until July 10, 2015 and make conforming changes to rule cross-references. By its terms, the effectiveness of the rule had lapsed on July 10, 2011. NASDAQ is reinstating the rule in order to ensure that NASDAQ has the same exemptive authority as FINRA with regard to the application of OATS rules, to ensure that its respective members are not subject to disparate requirements."
- 2. On page 20 of the original filing, delete the text of proposed rule 7470A and replace it with the following text:

## [6958] 7470A. Exemption to the Order Recording and Data Transmission Requirements

- (a) Pursuant to the Rule 9600 Series, Nasdaq, for good cause shown after taking into consideration all relevant factors, may exempt subject to specified terms and conditions, a member from the recording and order data transmission requirements of Rules [6954 and 6955] 7440A and 7450A, respectively, for manual orders, if such exemption is consistent with the protection of investors and the public interest, and the member meets the following criteria:
- (1) the member and current control affiliates and associated persons of the member have not been subject within the last five years to any final disciplinary action, and within the last ten years to any disciplinary action involving fraud;
- (2) the member has annual revenues of less than \$2 million;
- (3) the member does not conduct any market making activities in Nasdaq Stock Market equity securities:
- (4) the member does not execute principal transactions with its customers (with limited exception for principal transactions executed pursuant to error corrections); and
- (5) the member does not conduct clearing or carrying activities for other firms.
- (b) An exemption provided pursuant to this Rule shall not exceed a period of two years. At or prior to the expiration of a grant of exemptive relief under this Rule, a member meeting the criteria set forth in paragraph (a) above may request, pursuant to the 9600 Series, a subsequent exemption, which will be considered at the time of the request consistent with the protection of investors and the public interest.
- (c) This Rule shall be in effect until July 10, [2011] 2015.
