Partial Amendment No.1 to SR-NASDAQ-2014-080

The NASDAQ Stock Market LLC (“NASDAQ”) is filing this Partial Amendment No. 1 to SR-NASDAQ-2014-080 to make the following changes to the pending 19b-4 and Exhibit 1:

1. The name of the “PowerShares Diversified Commodity Strategy Portfolio” is replaced with the new name “PowerShares DB Optimum Yield Diversified Commodity Strategy Portfolio” in the first paragraph on page 3 of 66 of the 19b-4 and in the second underlined heading on page 10 of 66 of the 19b-4, as well as in the heading of the Exhibit 1 and in the second full paragraph on page 34 of 66 of the Exhibit 1 and in the second underlined heading on page 41 of 66 of the Exhibit 1.
2. The name of the “PowerShares Balanced Commodity Strategy Portfolio” is replaced with the new name “PowerShares Bloomberg Commodity Strategy Portfolio” in the first paragraph on page 3 of 66 of the 19b-4 and in the first underlined heading on page 12 of 66 of the 19b-4, as well as in the heading of the Exhibit 1 and in the second full paragraph on page 34 of 66 of the Exhibit 1 and in the first underlined heading on page 43 of 66 of the Exhibit 1.

The proposal SR-NASDAQ-2014-080, as amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5) because it makes technical and clarifying changes to the filing and does not make any changes that are unique or novel. Partial Amendment 1 specifically only changes the names of two of the funds included in the filing: the PowerShares Diversified Commodity Strategy Portfolio to the PowerShares DB Optimum Yield Diversified Commodity Strategy Portfolio and the PowerShares Balanced Commodity Strategy Portfolio to the PowerShares Bloomberg Commodity Strategy Portfolio.
