**Partial Amendment No.1 to SR-NASDAQ-2015-021**

The NASDAQ Stock Market LLC is filing this Partial Amendment No. 1 to SR-NASDAQ-2015-021 to make the following changes to the pending 19b-4 and Exhibit 1 to reflect that the filing was submitted to the Securities and Exchange Commission, and was effective, on March 6, 2015 and not March 5, 2015, a day on which the Federal Government was closed:

1. Delete the date March 5, 2015 and replace it with March 6, 2015 in section 2 on page 3 of 21 of the 19b-4, and again in the first paragraph on page 11 of 21 and in section I on page 11 of 21 of the Exhibit 1.

The proposal SR-NASDAQ-2015-021, as amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5)<sup>1</sup> because this Partial Amendment 1 only corrects the effective date of the filing, which was erroneously entered as a day that the Federal Government was closed.
