**Partial Amendment No.1 to SR-NASDAQ-2015-023**

The NASDAQ Stock Market LLC (“NASDAQ”) is filing this Partial Amendment No. 1 to SR-NASDAQ-2015-023 to make the following changes to the pending 19b-4 and Exhibit 1:

1. In the first two lines on page 7 of 52 of the 19b-4, as well as in the last two lines (excluding footnotes) on page 31 of 52 of the Exhibit 1, replace the words “not less than 80% of its” with “the Fund’s”.
2. In the first sentence below “Investment Restrictions” on page 8 of 52 of the 19b-4, as well as in the first sentence below “Investment Restrictions” on page 33 of 52 of the Exhibit 1, replace the words “not less than 80% of its total” with “its”.

The proposal SR-NASDAQ-2015-023, as amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5) because it makes technical and clarifying changes to the filing and does not make any changes that are unique or novel. Partial Amendment 1 specifically clarifies that under normal market conditions that the Fund will invest all of its assets only in those assets listed under the “Principal Investments” section.
