**Partial Amendment No. 2 to SR-NASDAQ-2015-036**

The NASDAQ Stock Market LLC (“Nasdaq”) is filing this Partial Amendment No. 2 to SR-NASDAQ-2015-036 to make the following change to the pending 19b-4 and Exhibit 1:

1. Add a footnote that states “The free website will be [www.eatonvance.com](http://www.eatonvance.com) or [www.nextshares.com](http://www.nextshares.com).” at the end of the second to last sentence of the first partial paragraph on page 12 of 54 of the 19b-4; and again following the end of the first partial sentence of the first partial paragraph on page 38 of 54 of the Exhibit 1.

The proposal SR-NASDAQ-2015-036, as amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5) because it makes a technical and clarifying change to the filing and does not make any changes that are unique or novel. Partial Amendment No. 2 specifically adds a website reference to the filing.
