SR-NASDAQ-2016-008 Amendment No. 1

The NASDAQ Stock Market LLC (“NASDAQ”) is filing this Amendment No. 1 to SR-NASDAQ-2016-008 to make the following changes to the pending 19b-4 and Exhibit 1:

1. In a new footnote to be added at the end of the sentence that ends with “will no longer be held in a suspended state” in the eighth line of the last full paragraph, on page 6 of 24 of the 19b-4, as well as at the end of the sentence in the second to last line that ends with “will no longer be held in a suspended state” on page 16 of 24 of the Exhibit 1, insert the following as the footnote: “The Exchange, however, will not accept orders for a security prior to having its registration statement declared effective.”.

The proposed SR-NASDAQ-2016-008, as amended, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5), because it makes a clarifying change to the filing. Amendment No. 1 specifically clarifies that the Exchange will not accept orders for a security prior to having its registration statement declared effective.
