1. Text of the Proposed Rule Change

(a) The Nasdaq Stock Market, LLC (“Nasdaq” or the “Exchange”), pursuant to Section 19(b)(1) of the Securities Exchange Act of 1934 (“Act”)¹ and Rule 19b-4 thereunder,² is filing with the Securities and Exchange Commission (“SEC” or “Commission”) a proposal to correct an inadvertent error in a recent filing and amend The Nasdaq Options Market LLC (“NOM”) Rules at Chapter 1, Section 1 Definitions.³

The Exchange requests that the Commission waive the 30-day operative delay period contained in Exchange Act Rule 19b-4(f)(6)(iii).⁴

3. Self-Regulatory Organization's Statement of the Purpose of, and Statutory Basis for, the Proposed Rule Change

a. Purpose

The Exchange proposes to correct an inadvertent error to a recent filing.⁵ The filing it is correcting was designed to align the NOM Rules with those of the Nasdaq ISE, LLC rulebook. The Exchange added several definitions to Section 1 of Chapter I, but did not delete the legacy definitions located in Sections 1(a)(7), (57), and (64). The legacy definitions are being deleted because they are already covered in Sections 1(a)(72) – (74). The proposed change is of a non-substantive nature and will simply delete the legacy definitions to avoid potential confusion.

b. Statutory Basis

The Exchange believes that its proposal is consistent with Section 6(b) of the Act,⁶ in general, and furthers the objectives of Section 6(b)(5) of the Act,⁷ in particular, in that it is designed to promote just and equitable principles of trade, to remove impediments to and perfect the mechanism of a free and open market and a national market system, and, in general to protect investors and the public interest.

The Exchange believes that by removing the legacy definitions for the terms “class of options”, “series of options”, and “underlying security” from the NOM rulebook

will help remove impediments to and perfect the mechanism of a free and open market and a national market system, and, in general to protect investors and the public interest through lessening potential confusion and adding clarity for market participants.

4. Self-Regulatory Organization's Statement on Burden on Competition

The Exchange does not believe that the proposed rule change will impose any burden on competition not necessary or appropriate in furtherance of the purposes of the Act. The proposed rule changes is to correct an inadvertent error and intended to lessen potential confusion with the Exchange's Rulebook, and therefore does not unduly burden competition.

5. Self-Regulatory Organization's Statement on Comments on the Proposed Rule Change Received from Members, Participants, or Others

No written comments were either solicited or received.

6. Extension of Time Period for Commission Action

7. Basis for Summary Effectiveness Pursuant to Section 19(b)(3) or for Accelerated Effectiveness Pursuant to Section 19(b)(2)

The foregoing rule change has become effective pursuant to Section 19(b)(3)(A)(iii)⁸ of the Act and Rule 19b-4(f)(6) thereunder⁹ in that it effects a change that: (i) does not significantly affect the protection of investors or the public interest; (ii) does not impose any significant burden on competition; and (iii) by its terms, does not become operative for 30 days after the date of the filing, or such shorter time as the Commission may designate if consistent with the protection of investors and the public

interest.

The Exchange does not believe that proposed rule change will significantly affect the protection of investors or the public interest because it would remove definitions that have been replaced in a recent filing.¹⁰ Moreover, the Exchange does not believe that this proposal will impose any significant burden on competition because, as explained, the change is non-substantive and is intended to lessen potential confusion with the Exchange's Rulebook, and therefore does not unduly burden competition. Additionally, the Exchange believes that by removing the legacy definitions discussed above from the NOM rulebook will help remove impediments to and perfect the mechanism of a free and open market and a national market system, and, in general to protect investors and the public interest through lessening potential confusion and adding clarity for market participants.

Furthermore, Rule 19b-4(f)(6)(iii) requires a self-regulatory organization to give the Commission written notice of its intent to file a proposed rule change under that subsection at least five business days prior to the date of filing, or such shorter time as designated by the Commission. The Exchange has provided such notice.

At any time within 60 days of the filing of the proposed rule change, the Commission summarily may temporarily suspend such rule change if it appears to the Commission that such action is: (i) necessary or appropriate in the public interest; (ii) for the protection of investors; or (iii) otherwise in furtherance of the purposes of the Act. If the Commission takes such action, the Commission shall institute proceedings to determine whether the proposed rule should be approved or disapproved.

A proposed rule change filed under Rule 19b-4(f)(6) normally does not become operative prior to 30 days after the date of filing. Rule 19b-4(f)(6)(iii), however, permits the Commission to designate a shorter time if such action is consistent with the protection of investors and the public interest. The Exchange requests that the Commission waive the 30-day operative delay contained in Rule 19b-4(f)(6)(iii) so that it may correct the inadvertent error and remove the legacy definitions. The Exchange believes that granting the waiver will further the protection of investors and the public interest because it will lessen potential confusion and add clarity for market participants.

Pursuant to Section 19(b)(1) of the Securities Exchange Act of 1934 (“Act”),¹ and Rule 19b-4 thereunder,² notice is hereby given that on August 2, 2019, The Nasdaq Stock Market LLC (“Nasdaq” or “Exchange”) filed with the Securities and Exchange Commission (“SEC” or “Commission”) the proposed rule change as described in Items I, II, and III, below, which Items have been prepared by the Exchange. The Commission is publishing this notice to solicit comments on the proposed rule change from interested persons.

I. Self-Regulatory Organization’s Statement of the Terms of Substance of the Proposed Rule Change

The Nasdaq Stock Market Rules

* * * * *

Options Rules

Chapter I General Provisions

Sec. 1 Definitions

(a) With respect to these Exchange Rules, the following terms shall have the meanings specified in this Section 1. A term defined elsewhere in the Rules of the Exchange shall have the same meaning with respect to this Chapter I, unless otherwise defined below.

* * * * *

(7) Reserved[The term "class of options" means all options contracts of the same type and style covering the same underlying security].

* * * * *

(57) Reserved[The term "series of options" means all options contracts of the same class of options having the same exercise price and expiration date].

* * * * *

(64) Reserved[The term "underlying security" means the security that the Clearing Corporation shall be obligated to sell (in the case of a call option) or purchase (in the case of a put option) upon the valid exercise of an options contract].

* * * * *
