

SR-NASDAQ-2021-066 Amendment No. 1

The Nasdaq Stock Market LLC (“Nasdaq”) is filing this Amendment No. 1 to SR-NASDAQ-2021-066 to make the following changes to the pending 19b-4 and Exhibit 1:

1. In the second sentence of the first full paragraph on page 35 of 102 of the 19b-4, as well as in the second sentence of the first full paragraph on page 85 of 102 of the Exhibit 1, replace “five” with “2,000”.
2. In the third sentence of the first full paragraph on page 35 of 102 of the 19b-4, as well as in the third sentence of the first full paragraph on page 85 of 102 of the Exhibit 1, replace “only five” with “2,000”.

The Exchange believes that the proposed rule change, as modified by this amendment, remains consistent with the Securities Exchange Act of 1934, and specifically with Section 6(b)(5), because it makes technical and clarifying changes to the filing and does not make any changes that are unique or novel. Partial Amendment 1 specifically clarifies that the CME has set a position limit of 2,000 contracts for the CME Bitcoin Futures.

All other representations in the filing remain as stated therein and no other changes are being made.
